The Zoom meeting was called to order at 6:31 pm by President Marilyn Casiano. Sue C made a motion to accept the corrected March 2021 board minutes and Dawn F 2nd the motion. The motion carried.

President – Marilyn shared her excitement about all the new potential members and upcoming obedience and rally trials.

Treasurer – Dawn gave a complete financial report giving the amount in all club accounts. The club was reimbursed \$1900 from Animal Planet which included a \$500 donation and \$1400 in expenses.

A motion was made by Mike D to accept the treasurers report as presented. Dean D seconded and the motion carried.

The club has received \$1,026 so far from the first obedience trial. There will be 6 trials total. To date, AKC has only charged us for 2 trials at \$200. All ribbons, flat and rosettes, have cost the club \$250. Food will be offered on site at the trials. So far

judges' expenses are/will be Nancy Craig at \$300/show and Janis at \$100 plus gas.

Show Report – Time to start working on the 2022 show. Dawn will contact Travis to confirm our date at the park. Those in charge of our “extras” will reach out and make sure they are a go for 2022. We will offer NOHS and Beginner Puppy 4-6 months at both shows. We will offer veterans on Saturday.

Debby Boehm explained to the membership that they have been doing dry runs, set ups, etc to prepare for the upcoming obedience and rally trials. They are excited for the trials to happen and plan to make the club proud!

Unfinished Business – The slate has been presented to the membership by the nominating committee. There were no nominations made from the floor. Dean D moved that all nominations be closed and the slated accepted as presented. Dawn F seconded the motion. All were in favor and the motion carried.

New Business – Seven potential membership applications were read to the membership.

A complete delegates report was made by Leeann Stusnick.

Dean D made a motion to adjourn the meeting at 7:14 pm and Jeff N seconded the motion. The motion carried and the meeting was adjourned.
