Kachina Kennel Club Board Meeting Minutes - August 18, 2020

Members in attendance were Stephanie Clark, Dawn Fennewald, Ashley Jimenez, Sue Caniff, Marilyn Pauley and Marilyn Casiano.

The teleconference (ZOOM) meeting was called to order at 6:36 PM by President Marilyn Casiano. Ashley Jimenez motioned to accept the July 2020 Board Minutes as published in the Newsletter. Sue Caniff 2nd and the motion carried.

President: No Report

Vice President: Absent

Secretary: No Report

Treasurer: Dawn gave a complete financial Report giving the amount in the checking account as well as the money in the Kachina PayPal account, and stated that the club money is continuing to grow even during the pandemic. Sue C. made a motion to accept the Treasurer Report as presented. Marilyn C. 2nd and the motion carried.

Show Chairman: We have all of the judges for the Show. Dawn stated that she talked to Travis at the City of Surprise, and received the rental contract for the park. The rental price is the same as last year. We are still waiting to see if we will be able to host our January show as all events at the park have been cancelled at the park through the fall. We are questioning if we will get our deposit back or if it will be applied for our next event. Dawn is waiting to make reservations on renting tents and golf carts since we would probably lose the deposits. Discussion on whether or not to have the show a Non-Spectator event ensued. Dawn said she will check with Travis to see if we can restrict spectators at the park.

Discussion on how many entries we should consider for this show. It was determined to limit the conformation entries to 1300, as we have space for that number of rings, and judges to cover that number.

How to handle grooming spaces. It was determined that we will have to use a form that would be filled out and sent to us. Spaces will be determined by post-mark on envelop should all spaces sell out. We will have two food vendors this year. Rich all around food vendor and one more regular vendor with dessert.

New Business: The Board had a discussion on trying to hold a General Meeting with all members via telecommunications on Zoom. The board decided that we will try one meeting to see how it goes, and agreed to start in September which is our normal month to reconvene after our summer break. Stephanie will write up the instructions and Marilyn C will send them to the membership. Ashley suggested a board/group meeting with any potential new members. Marilyn C suggested that for now new applicants meet with the Board and when General Members meetings start back up they attend 2 general meetings and that the membership vote on the 2nd general meeting. This is a slight modification of the Constitution.

Unfinished Business: it was decided to repeat this unfinished business from last month again in this newsletter. "A question came up regarding the best way we can handle the Awards from the club, since once again the Pandemic has caused the closure of Show events for a large portion of the calendar year.
