Dawn stated that all of the valid award requests will be read at the May meeting, but that the actual Bars and Plaques will be handed out at a later meeting, once the engraving is completed. Also to save money all of the titles earned by the same dog will be listed on one bar. This is to cut down on the engraving expenses. Members can purchase individual bars if they so chose, but the last title earned plus all previously earned titles will appear on the bar offered by Kachina.
