## **Kachina Kennel Club General Meeting Minutes - September 15, 2020**

Members in attendance were Maggi Lieber, Lee Ann Stusnick, Susan Howard, Yvonne Cockrill, Marilyn Pauley, Sue Caniff, Stephanie Clark, Ashley Jimenez, Dawn Fennewald and Marilyn Casiano.

The teleconference (ZOOM) General meeting was called to order at 6:30 PM by President Marilyn Casiano. Maggi Lieber made a motion to approve the minutes as presented in the newsletter, seconded by Sue Caniff.

**President:** Marilyn C announced that she received a letter from Susan Miller-Brittan resigning from the Vice President position, and asking to stay on the board as a Director. This letter was read to the Board on September 8, 2020. Marilyn asked the Directors if any of them was willing to exchange positions and Sue Caniff stated she would. A motion from Ashley to accept Susan's resignation. Dawn F seconded. The motion passed. Dawn F made a motion to accept Sue Caniff as Vice President and Susan Miller-Brittan as Director. The motion was 2nd by Marilyn and the motion carried. (Again, this transpired at the KKC Board meeting September 8, 2020. It was also discussed at this Board meeting that all board members will have to abide by the Constitution in requirements for meeting attendance.)

**Vice President:** No Report

**Secretary:** No Report

**Treasurer:** Dawn F gave a complete accounting of the financial accounts and stated that we earned \$5,300.00 earned on the Facebook raffles that are designed for Dog Clubs to make money during the pandemic. A motion to accept the Treasurer's report was made by Yvonne C. and 2nd by Susan Howard. Motion passed unanimously.

**Show Chairman:** Dawn reported that all paperwork was given to Onofrio. We purchased new titling ribbons that will be for all Kachina show events. Dawn also stated that the Arizona Toy Dog Fanciers, Bulldog Club, the Doberman Club and the Miniature Schnauzer Club will be our show. Also Dock Diving and Fast CATS will be with our show. Dawn stated that our show is at the mercy of the City of Surprise, and that there will be no spectators. It will be a Show and Go event with entrance and exit at the main gates at two main gates and that we will require a signed waiver for all persons attending the show. We may possibly have wristbands for exhibitors. We will have at least 2 food trucks for this show. Mask will be worn for all persons on the show grounds. Discussion ensued about masks to be worn outside show grounds in the parking, food and vendor area. We will only have 2 vendors, Store 4 Dogs and another all show product vendor, which will be announced shortly. Our AKC Delegate Lee Ann Stusnick, was in attendance and gave a report on some of the dog shows that took place in Oklahoma and other Midwest shows. She stated that they clubs did temperature checks, had wristbands and arm bands as you entered the show grounds. AKC is allowing clubs to hold show over 3 days due to the limited entries. This will be allowed through July 2021. Dawn explained that we are only doing the regular Show and no extra special events such as 4-6 month puppy. We are working on trophies. We have all of our judges. Specialties have their information in to Onofrio for the premium, and we are limiting the show conformation entries to 1400/day. This limit is only for KKC conformation.

**Unfinished Business:** A question came up regarding the best way we can handle the Awards from the club, since once again the Pandemic has caused the closure of Show

events for a large portion of the calendar year.
